## Healthcare Reform - Your Urgent Action is Needed

Health care reform legislation continues to be an item of critical importance for persons with disability and those that minister with them. As the House and Senate bills move toward conference to adopt a single bill, the voice of those who advocate for the protection of life, and particularly people with disabilities and children who are yet to be born, remains one that is of particular importance. In order that the perspective of people with disabilities is heard, we include the following message and materials from the USCCB. Please take a moment to read and act upon their request.



Dear colleagues,

As you are aware, the House and Senate have begun discussing how to meld their respective health care reform bills into a final bill. The bishops continue to advocate that the following moral criteria are met in the final bill: 1) maintain current conscience protections and prohibition on federal funding for abortions and abortion coverage; 2) provide adequate and affordable coverage for all people, especially the poor and vulnerable; and 3) protect access to coverage and health care for immigrants .

The expectation is that the negotiations will continue through January with the goal of having a bill signed into law before the State of the Union address (date to be determined).

It is important to share the attached materials **as soon as possible**. The negotiations are happening now and the leadership needs to hear from their constituents to urge support for the following:

1. maintain the prohibition on federal funding for abortion;
2. include adequate and necessary conscience protections;
3. incorporate the best affordability provisions from each bill;
4. protect immigrants by allowing them to buy insurance with their own

money and for legal immigrants to have access to Medicaid regardless of date of entry.

As soon as leadership reaches an agreement, there will be floor votes (there won't be much time to get materials out at the point).

Many men and women with disabilities have responded to God's call to serve as priests or religious. During this **Year for Priests** NCPD is highlighting many of their stories. Thanks to Ann Sherzer, Director of Ministry with Persons with Disabilities for the Diocese of Kalamazoo MI, for the following article on St. Jean Vianney and the priest (M. Bailey) who guided him in his vocation.

## Everyone Needs an Advocate

On August 4, the Church celebrates the feast of St. John Vianney, the patron saint of parish priests. John Vianney was known as a wise and compassionate pastor and confessor. People would travel great distances to Ars, France to hear him preach and receive his counsel.

John Vianney heard the call to priesthood early in life but his father would not allow him to leave the family's poor farm until he was 19. In preparation for seminary he studied with M. Bailey, the pastor or Cure of Ecully.

For 10 years, John struggled with academic work. M. Bailey was his advocate and surest source of encouragement. When asked to leave the seminary because of poor grades, M. Bailey took John in for more tutoring. At the end of the year this good man convinced the seminary Rector to let John take his exams with the rest of the class. When he failed these tests, M. Bailey convinced the Rector to examine him orally in French rather than the usual Latin. When finally ordained, John, who was to become a famous confessor, was not given faculties to hear confessions until some months later when he finally passed his course in moral theology. No doubt he was once again coached by the faithful M. Bailey.

August 4 is the feast of St. John Vianney but what about M. Bailey? Perhaps each time someone recognizes the gifts of another and advocates for the full use of those gifts we should remember M. Bailey. Certainly it would have been easier for him to tell his slow student "It's too hard you'll never make it, return to the farm."

### Don't Cut Support for People with Disabilities

Advocacy for people with disabilities includes letting our state and federal legislators know that funding for people with disabilities is a critical lifeline for many. Please let them know your opinion on this as budgets are being drawn up, and specific bills are being considered. Besides the health care reform that is spoken to in the feature article above, there is also legislation pending on the National Housing Trust Fund (NHTF). This measure passed the House of Representatives with a \$1 billion investment package and will likely be voted on in the Senate in early January. Also at stake are potential cuts to mental health services which are aided by the federal Medicaid match rate. Please [click here](#) to read more about it on NAMI's web page. The Access Board is an independent Federal agency which is a leading source of information on accessible design. The Board develops and maintains design criteria for the built environment, transit vehicles, telecommunications equipment, and for electronic and information technology. It also provides technical assistance and training on these requirements and on accessible design and continues to enforce accessibility standards that cover federally funded facilities.

The Board is structured to function as a coordinating body among Federal agencies and to directly represent the public, particularly people with disabilities. Half of its members are representatives from most of the Federal departments. The other half is comprised of members of the public appointed by the President, a majority of whom must have a disability.

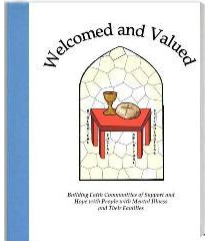
## Compilation of Federal Disability Statistics
